OUR INSPIRATION AND OUR INTENT

The Accelerated Pathway to USD Law is a new opportunity that allows high-achieving UC San Diego undergraduates to earn both their bachelor's and law degrees in six years.

STEP 1: EARLY IDENTIFICATION AND INVITATION TO APPLY TO BECOME A PATHWAY PARTICIPANT

Current Requirements:

- (a) 3.7 overall GPA,
- (b) Successful completion of at least three Public Law courses in the Department of Political Science (POLI 104 A through 104Z)
- (c) on track to graduate from UC San Diego within three years for first-year admits (assessed at end of winter quarter of students second year at UCSD) or within two years for transfer admits (assessed at end of winter quarter of transfer student's first year at UCSD)



STEP 2: FULFILL PATHWAY PARTICIPANT PRESUMPTIVE ADMISSION STANDARDS

- (a) Earn requisite minimum score on LSAT summer before last year at UCSD (164 currently, for first Pathway class TBD, but will be comparable)
- (b) Submit USD Law application by October 1 (last year at UCSD) Dean Chavez to Discuss

Optional: Encouraged attendance at workshops, visits to USD, and other programming to prepare for the transition to USD Law School

Note: USD Law School will admit 25 Pathways Participants each year under this Accelerated Pathway program (USD discretion to accept more). Admitted Students may choose to decline the admissions offer from USD Law School opening room for others to be admitted.



STEP 3: ADMISSION TO USD AND OFFER ACCEPTANCE

- (a) Offers and any scholarship notices will be sent to Presumptive Admits by December 22.
- (b) Presumptive admits must commit with seat deposit by January 15.
- (c) Celebration and Special programming January through June for students admitted and bound for USD Law to build an early relationship with their new institution and to ensure they thrive in their first year of law school at USD Law!

FREQUENTLY ASKED QUESTIONS/OTHER QUESTIONS

- Open to all majors
- Pathway Participants admitted separately from general USD Law applicants (can still be admitted to USD Law outside of this program)
- Timeline: We will identify and invite students who fulfill criteria under Step 1 (early identification and invitation to become a Pathway Participant) at end of winter quarter 2026

LSAT – Summer 2027
Presumptive Admission – Fall 2027/Winter 2028
Graduate UCSD –Spring 2028
Matriculate to USD Law – Fall 2028

UCSD Invitation To Apply End of Winder Quarter 2nd Year

Qualifying UCSD students are identified and invited to apply

Current Requirements:

- (a) 3.7 overall GPA
- (b) Minimum of 3 Public Law Classes
- (c) On track to graduate in 3 years

UCSD-Led Pathway Programming Spring Quarter 2nd Year

UCSD Pathway student programming in collaboration with USD Law Spring Quarter, 2nd Year (e.g. JD application workshops, 1:1 JD advising, mock law class at USD Law and campus tour, LSAT primer courses)

Comprehensive LSAT Prep.

Summer Between 2-3rd Year

Following the completion of 2nd year studies at UCSD, students begin a comprehensive summer LSAT preparation program focused on maximizing their test-taking potential for their upcoming LSAT exam

USD Law Admission Notices Fall through Winter 3rd Year

Continued Pathway Programming Fall Quarter 3rd Year

USD Application Submission October 1st Deadline, Fall 3st Year

tinued Pathway Programming Spring Quarter through graduation

Admitted students secure their seat in the incoming USD Law first-year class by submitting a full seat deposit by January 15th

Admitted students can decline an offer of admission before or after the deposit deadline All admitted Pathway Participants will receive their admission notices and scholarship letters - if eligible, by by December 22nd

Prior to USD Law Orientation Week, incoming students participate in in communitybuilding and academic successfocused events (e.g. Padres game, Mentor Collective, Summer Seminar, JD Immersion Week) Following presumptive LSAT and GPA admission parameters, USD Law will admit 25 Pathway Participants each year under the Accelerated Pathway program and, may at its discretion, accept more
